before 21 days from date of entry of this order. It is further

ORDERED that compensation shall be paid to Special Counsel upon notice, hearing and

approval by the court pursuant to 11 U.S.C. §§330 and 331 and Bankruptcy Rule 2016 of an

appropriately detailed application therefor, to be served upon the United States Trustee.
